1. Basic information

QNT (Quant) is a token created by Quant Network, a company focused on interoperability and blockchain solutions. Its primary purposes are:

- Overledger Network Access. QNT is used to pay for access to Quant's Overledger Network, a platform designed to connect different blockchains and enable interoperability between them.
- **License Fees**. QNT is required to pay for licenses and services within the Quant ecosystem, such as using their API and other enterprise-grade tools.

The token has evolved from a simple utility token to a key component in enabling cross-chain communication and enterprise blockchain adoption, positioning itself as a bridge between traditional finance and decentralized systems.

2. Analysis

On the tech side, QNT is an ERC-20 token (deployed on Ethereum) that fuels Overledger, a Layer 2 interoperability solution. It employs a proprietary consensus mechanism, positioning it as an innovative player in cross-chain communication.

While QNT is categorized as a 'utility' token and lacks an official ISO certification, some team members have backgrounds in ISO-related roles. Notably, while Quant has not undergone third-party audits for its own token, the company provides auditing services for other blockchain projects—adding a layer of credibility.

Additionally, Quant does not currently have a bug bounty program in place.

In the strategy block, QNT excels as a mature project with a clear public roadmap, a doxxed team, and strategic partnerships (e.g., BIS, Bank of England, NHS). Its active social media presence further strengthens community engagement and transparency.

Quant operates under a centralized governance model, meaning key decisions are made by the core team or a select group rather than being decentralized among token holders. The project is partly open source, with certain components of its technology available for public review while other elements remain proprietary.

For tokenomics, QNT features a fixed supply with a deflationary touch—a one-time burn in 2018 destroyed nearly 1% of total circulation. Though it lacks recurring burns, collateral, or a buyback program, its scarcity and integral role in Quant's ecosystem justify an average tokenomics score.

Overall, the analysis has been carried out satisfactorily.
