#### 1. Basic information

Sky is a next-generation decentralized finance (DeFi) ecosystem that evolved from MakerDAO, one of the oldest and most successful DeFi protocols.

At the core of Sky are two upgraded tokens: USDS, a stablecoin, and SKY, the governance token. USDS serves as the upgraded version of Dai, offering users the option to convert Dai or USDC into USDS at a 1:1 ratio. Its primary purposes are:

- **Staking and Rewards**. Holders of USDS can earn SKY Token Rewards directly within the Sky Protocol, eliminating exposure to external risks. Alternatively, users can opt for the traditional Savings Rate, a proven yield mechanism.
- **Governance**. SKY, the governance token, replaces MKR, with MKR holders able to upgrade at a rate of 24,000 SKY per MKR. SKY introduces new governance incentives, including Sealed Activation, where users lock their tokens behind an exit fee to earn rewards, and Regular Activation, a more flexible option for earning rewards without long-term commitments.

With its focus on usability, rewards, and scalability, Sky aims to accelerate DeFi adoption, offering a seamless gateway for users to engage with decentralized finance.

On the one hand, the tech block shows that SKY is a layer 2 token built on Ethereum, leveraging Proof of Stake (PoS) for efficient and scalable governance. While it benefits from Ethereum's security and low fees, the absence of an ISO certification limits its compliance score.

However, it compensates with strong security measures, including audits by ChainSecurity and a bug bounty program hosted on Immunefi, ensuring robust protocol integrity.

On the strategy side, SKY operates under decentralized governance, with a clear roadmap published in its Atlas forum. Key partnerships with Gemini and Gnosis highlight its integration into the broader DeFi ecosystem. Though it lacks a public team - prioritizing decentralization - its active social media presence and transparent development process reinforce its credibility.

Finally, the token economy combines an infinite supply with deflationary mechanics. The Smart Burn Engine and Sealed Activation Exit Fee systematically reduce supply, while collateralization via Sealed Activation ties SKY to protocol stability. These mechanisms - paired with governance rewards and USDS backing - create a balanced system, earning SKY a tokenomics score of 3.

While the lack of buybacks and uncapped supply prevent a higher rating, its innovative burn and collateral strategies align with Sky's vision for sustainable DeFi growth.

Overall, the analysis has been carried out satisfactorily.
